DOCUMENTS TO COMPLY WITH SB14 ARE DUE NOW!

Topic: Every four (4) years by September 1st Hazardous Waste Generators who manifest >26,400 lbs. of hazardous waste (*that's about 3,000 gallons of aqueous waste*) or 24.6 lbs (*about 3 gallons*) of extremely hazardous waste are mandated to document their waste reduction efforts and develop reports and plans showing the results. Previous reports were submitted to DTSC, however compliance is now determined as part of the periodic inspections by the Orange County CUPA. Come learn what is required to be in your Source Reduction Evaluation Plan, Hazardous Waste Mgmt Report and Summary Progress Report so that you'll be in compliance once your CUPA Inspector arrives.

Speakers:

Terry Carrier, Supervising Hazardous Waste Specialist, OCHCA, OC CUPA, will present what SB14 requires and what inspectors will be looking for. This is a great opportunity to speak to your regulator **face to face** and ask the questions you need answered.
