Larry McKenney, Director of the Watershed and Coastal Resources Division of the County of Orange, is responsible for the County's stormwater program, water quality science, TMDLs, and watershed management. He graduated from the U.S. Naval Academy with a degree in history and accepted a commission in the U.S. Marine Corps. He later earned a law degree from the University of Texas School of Law. He served on active duty first in the artillery and later as a lawyer including working as the water lawyer for the Marine Corps' Western Area Counsel Office. Leaving active military service, he worked in the Law Offices of Susan M. Trager in Irvine before returning to Camp Pendleton as a civilian to head its Office of Water Resources. He joined the County of Orange in February 2002.
